ACADEMIC AUDIT 2021

The Academic Audit for 2021 of Lady Brabourne College, Govt. of West Bengal was conducted on 28.09.2021 & 9.10.2021 by Inspector of Colleges, University of Calcutta.

The following report is prepared on the basis of the observations, recommendations and suggestions of the auditor to the Principal, Prof Siuli Sarkar and members of the IQAC.

- ◆ Academic Audit conducted by Sri Debashis Biswas, Inspector of Colleges, University of Calcutta.
- ◆ Sri Debashis Biswas viewed the Principal's Overview, the Report of the IQAC and the report of the Women's Study Centre of the College on 28th September 2021. He also viewed Philosophy, Economics and Statistics departments. He next visited the College on the 9th of October 2021 to view the Humanities Departments.
- ◆ The Observations of the Auditor are as follows:
 - a) The unique strengths of the College like the achievements of Muslim students for whom the College had been originally founded, publications, research activities of Faculty and all round performance of the students to be fully highlighted.
 - b) The IQAC Coordinator was advised to reorganize the presentation to make it more focused as the matter was there.
 - c) The Departmental presentations were scrutinized carefully, both for the Arts and the Science streams. Sri Biswas and pointed out that the lay out for each stream had to be uniform.
 - d) Of the Language Departments, some were found to be on the right track. Others were advised to reorganize the presentation to showcase the achievements more comprehensively.
 - e) The Social Science Departments were thoroughly viewed and were advised how best to bring to the forefront the considerable academic achievements.
 - f) The Physical Science Departments were advised to draw attention to the laboratory set up which had been augmented by various grants.
 - g) The Bio Sciences were found to be well organized following the right steps.

h) The progression of Statistics, Economics and Mathematics reflected the diverse academic achievements of the students.

Overall Impression :

The HEI under Review definitely had a great deal of potential on the academic front and the list of achievements was commendable in this area. However the Auditor pointed out that for any HEI willing to develop and evolve there should not be any sense of complacency. To that end it was advisable that Faculty and Non-teaching Staff continue to put in maximum effort to create a very enriching space for the Primary Stakeholder.
